Estimated Value Rs 2760.00 lakhs.
2. Tender shall be submitted on or before 21-09-2017 up to 10.30 hrs.
3. The period of completion of job will be 220 days from the date of signing of contract as per (ref section-III, sl. no. (8) Time Schedule) Part -I of technical bid. Time is essence of the contract; contractor has to mobilize materials & labour to complete within 220 days time period.
4. The tenderer shall inspect the site of work and understand the scope of work before quoting.
5. All materials required for the work shall be arranged by the contractor unless until specified in Bill of Quantities.
6. This is a lump-sum rate contract and payment will be made as per the contract agreement.
7. The payment will be made in five stages as per Annexure-I specified in the price bid.
8. **Security Deposit** should be in the form of Bank Guarantee or DD in favour of MIDHANI from any Nationalized or scheduled bank for 10% value of contract and the same should be submitted within the 7 days from the date of signing of contract & should be valid till completion of contract plus defect liability period (1 year) along with 3 months claim period.
9. The security and safety rules of MIDHANI to be followed. The contractor shall take care of all labour laws regarding minimum wages, ESI, PF., Group Insurance etc., MIDHANI is no way responsible in this respect. MIDHANI is not liable for any claim in respect of any accidents or otherwise excepting to the extent of work completed as per the contractor.

10. MIDHANI reserves the right to operate partial or delete any item specified in BOQ without any compensation to contractor for the items non operated or deleted.
11. You should not cause any loss or damage to MIDHANI property / or personnel, if any loss or damage is caused the cost of the same will be recovered from your bills cost of loss or damage will be deducted by MIDHANI, which will be final.
12. If the work is abandoned / stopped without bringing proper notice to Engineer-in-charge, your contractor will be terminated and balance work will be carried out at the cost and risk of contractor.
13. **Liquidated Damages:** - (i) If the work is not completed within stipulated time. Liquidated damages @.1% per week delay to a maximum of 10% total value of Work order will be deducted. (ii) Also, if the delays are not attributed to contractor, the competent authority holds the right to waive of or reduce the LD as the case may be.
14. The offer shall be valid for 3 months from the date of opening of tender.
15. Incomplete or partially filled tenders will be rejected. MIDHANI reserves the right to accept or reject any or all tenders without assigning any reason.

**Note:-**

1. Two numbers Over Head Emergency Water Tank each of size 18m x 5m x 1.5m carrying only water to be considered along B row & C row in between Grid No.1 & No.3. Bottom of the tank will at (+) 30 meter level. Peripheral walkway (minimum 1.2 meter wide) around the tank with safety hand railing, access staircase from roof of building shall be considered for each tank. Water tank will be supplied & erected by MIDHANI. The Emergency Over Head Water Tank will be constructed of 10 mm thick steel plate for side wall & bottom, 5MM thick steel sheet for top cover. It will be supported & strengthened by suitable frame work consisting of angles, ISMC channels, flats etc. Weight of each overhead water tank will be about 40 Tons.
2. Utility Pipe line weight: Please refer drawing no: WP0FBN-AA00-B0500-AD008 attached herewith.
3. Electrical cable weight: Please refer drawing no: WP0FBN-AA00-B0500-AD008 attached herewith.
4. The lowest bidder will be decided based on lowest value of Total Amount Rs(1a + 1b) of Price bid (Schedule-A).
5. Providing & fixing of minimum two no`s dog-legged staircase on each side crane walkway of AB & BC bay. For 131m long building their will be minimum three staircase for each side crane walkways of DE & EF bay. Location of steel staircase will be finalized during detailing / at both the end of sheds, as per Industrial Design criteria. In addition one Caged Monkey ladder for each shed shall be provided outside the building for maintenance of roof/cladding for each shed.
6. All the bidders must quote the rate and quantity for sl no: 2 to 5 of the above price bid.
7. **ANCHOR BOLTS:** These are to be supplied prior to the delivery of Pre-Fabricated Building. Contractor has to deliver immediately after receipt of Prefab's anchor bolts setting plans (marked "FOR CONSTRUCTION") approved from PMO, MIDHANI.
8. **Louvers** shall be provided at two levels viz @+3.50 mtr & other one@ Crane platform level.
9. 1. " The bidders may consider uniform height of each bay matching with highest level of respective bay for crane maintenance or by considering the height of building/ each bay as per basic engineering drawing attached with this tender. However, the Bidder can submit only one Lump Sum price. Lowest bidder will be decided based on lowest value of Total amount (1a+1b) of Price d. "

2. One coat primer and two finish coats paint to be applied. Primer coat and one finish coat shall be applied at supplier's shop; second finish coat paint shall be applied at site before erection and touch up paint after erection of structure.
10. Payments to the contractor shall be based on the quoted price / Negotiated price thus arrived (Fixed Rate). No extra payment is admissible due to deviations or variations during execution of work or due to escalation in prices of materials and labour or due to reworking designs/modifications if any desired by or during the processes of tender.
11. In case of the scope of work is reduced by the deletion of works/services, the quoted price will be reduced and the reduced price thus arrived is valid for the payment.
12. In case of any discrepancy between words and figures in price quoted above, the quoted price written in words shall prevail.
13. The technical parameters for supply, fabrication, & erection of Industrial sheds are indicated at Volume –II of Technical bid.
14. GST as per statutory provisions shall deduct at source.
15. The contractor is required to study all the pages of this document before quoting.
16. MIDHANI reserves the right to reduce the price in case of reduction in scope of work on pro rata basis and on mutual discussion.
17. By signing this page the tenderer is hereby agrees to abide by all the terms & condition of this tender document including the technical bid and the condition there on.
